- 2. The licence is being granted with the explicit condition that you will use BIS. Standard Mark on entire/substantial production, which conforms to the Indian Standards referred above.
- 3. The number assigned to this licence is CM/L-4100039672 which has been made operative from 04/09/2017 and is valid upto 03/09/2018. The licence number should invariably be referred to in your future correspondence.

- 4. The annual licence fee of Rs.1000/- and the advance minimum marking fee of Rs. 96000/-(plus applicable service tax) as agreed by you, vide your letter No. NIL dated 28/06/2017 has been adjusted from the Invoice No. HQNDNT2017000120 dated 08/08/2017 for Rs. 96660.70 & Invoice No. HQNDPC2017000659 dated 04/09/2017 for Rs 1655.00 for the above-mentioned operative period. Please note that the marking fee, as agreed, is payable by you regardless of the fact whether you actually mark or not the product manufactured by you with the Standard Mark.
- 5. The actual marking fee shall be calculated on unit rate basis of the production marked as follows: Minimum Marking Fee Rs. 96000.00 Rs. 12.00 per unit for all units Unit = One Tonne

The fee shall be payable by you on quarterly basis, within a period of one month from every quarter. The calculated fee may, therefore, be sent regularly along with list of consignees with their complete postal addresses and other contact details such as phone and fax numbers, email, etc. In case you do not apply for renewal of the licence or the licence is not renewed, the entire production marked till the validity date shall be taken into account for calculating the marking fee payable. The fee may be revised on an annual basis or as specified by the BIS.

- 6. With a view to streamlining the reporting of quantity marked, calculation and collections of marking fee on the unit rate basis, fees will be calculated on the production marked during the first nine months of operation of the licence at the time of first renewal and the production marked during twelve months comprising the last three months of the previous operative year, at the time of second and subsequent renewals. Photographic reduction in any size is permissible. This will ensure the relative proportions of the different dimensions are maintained. Preferred dimensions may be used as far as possible. Kindly get the designs of the stencil/label/rating plate incorporating the Standard Mark approved by us. You will be permitted to commence marking the above mentioned product only after approval by this office.
- 9. On commencement of marking of your product for which you are licensed, you may advertise your product with Standard Mark in hoardings, slides and newspapers only during the validity of your licence. The use of Standard Mark on letterheads and publicity literature will be permitted only on receipt of your assurance that in the event of cancellation or lapsing of your licence, the letterheads etc. with the Standard Mark will be destroyed/obliterated. The required assurance may please be submitted in the enclosed proforma.
- 10. You are requested to intimate us the actual date from which you intend to introduce the use of Standard mark on your product. You may seek any information/assistance in adopting the Scheme of Testing and Inspection (STI) and in the maintenance of test records, if required.
- 11. Kindly inform the grievance redress system you would provide to consumers after the material is sold and complaints are received regarding sub-standard quality of the Standard Marked product.




